The Festival Committee will evaluate each booth and reserves the right to deny space or individual items in a space at any time, which are not the highest handmade quality and to request vendor to remove products, works or displays considered objectionable to the public or inappropriate for a family event and may do so without refund to exhibitor. Exhibitors in violation of any of the rules listed or who add market type items to their booth may be asked to leave.
  2. **This entry form must be filled out in its entirety and be accompanied by application fee and 2 different photographs** of a grouping of the arts & crafts being exhibited. Photographs **will not** be returned and may be used in festival advertising.
  3. Nominal Security is provided between 7PM to 7 AM Friday & Saturday.
  4. Exhibitors are responsible for collecting, reporting and paying all sales taxes collected to the appropriate revenue division.
  5. Parking is not allowed by vendors on the **East Side & West Side** of Spring Park, thereby allowing easy access for potential customers.
